#### CALL TO ORDER:

Chairman Fields the meeting to order at 3:31 p.m. After roll call it was noted that seven (7) members were present representing the appropriate number of members for a quorum.

### **APPROVAL OF MINUTES FOR NOVEMBER 15, 2019**

Commissioner Bridwell noted a correction from the November 15, 2019 minutes as mailed. The Right of Way Deed dated January 8, 1968 is recorded in the Register of Deeds Office on Book # 171 Page 254 not Book #176 Page #114 as the minutes reflected. Commissioner Thacker made a MOTION to approve the minutes with the correction, and Commissioner Gibson made a second. Motion passed unanimously.

#### OTHER BUSINESS:

## A. New Names added to the Road List: Brigade, Edgar Trent, and Wallace Road

Commissioner Bridwell explained the reasons he questioned the new roads that were added to the road list, and presented to the County Commission. Resolution number 2019-03-03 was pulled from the Commission vote after Commissioner Bridwell questioned the new roads during the Commission meeting. Bridwell explained that he felt he didn't have enough information prior to the meeting to make a decision on the Resolution. Chairman Fields explained the process for establishing a new road in Hawkins County. He also explained that the two (2) roads in question, Wallace Road, and Edgar Trent Road, were already maintained roads in Hawkins County, but they

had never been given a name. The third road in question, Brigade Road, was also an existing maintained road in Hawkins County that branched in two different directions. After some discussion Commissioner Thacker made a MOTION to accept the three new road names and and send the resolution back to the County Commission. Commissioner Talley seconded, and the motion passed unanimously.

#### B. Speed Limit on Bradley Creek Road

Commissioner Thacker stated he wanted to bring the speed-limit increase on Bradley Creek Road back to the full commission. After a presentation from Chief Deputy Tony Allen, a resolution failed in the full commission vote to increase the speed limit from forty five (45) to fifty five (55) miles per hour. Commissioner Thacker stated he had driven Bradley Creek Road at speed limits of sixty-five (65) to seventy (70) miles per hour, and had videoed the drive. He stated several others had driven the road at higher rates of speed, and did not feel any danger driving over the forty-five mile and hour limit. Commissioner Bridwell expressed his concerns of the large trash trucks traveling the road daily. Bridwell was concerned the speed limit was set to prevent the large trucks, with extremely heavy loads, from traveling at a high rate of speed. After some discussion concerning the speed limit on Bradley Creek Road, Commissioner Thacker made a MOTION to recommend to the full commission to raise the speed limit on Bradley Creek Road from 45 mph to 55 mph. Commissioner Gibson made a second, and motion passed by roll call vote as follows:

#### C. Beauty Salon Road

Commissioner Brewer asked that the committee consider renaming Beauty Salon Road located in his district to Livesay Road. Brewer explained when 911 came along a beauty shop was located on that road. 911 officially named the road Beauty Salon Road. The road had previously been called Fate Livesay Road. Brewer explained he lived on the road, as well as other households. All residents were in agreement to change the road name to Livesay Road. After some discussion, Commissioner Thacker made a MOTION to rename Beauty Salon Road to Livesay Road, Commissioner Gibson made a second, motion passed unanimously with Commissioner Brewer abstaining from the vote.

## **ADJOURN:**

There being no further business to be considered by the Committee on this date, a MOTION was made by Commissioner Talley, and seconded by Commissioner Thacker to adjourn. The meeting was adjourned at 4:11 p.m.
