WHEREAS, no new Emergency Communications services have been secured further putting at risk Police, Fire Services & Emergency Medical Services and,

WHEREAS, a maximum of \$30,000.00 can be used to restore services and equipment: this amount does not include the actual contract with AMK Services.

NOW THEREFORE BE IT RESOLVED that the Hawkins County Commission restore and continue the communications contract with AMK Services effective upon agreement being reached with AMK Services and the Public Safety Committee and to continue through December 31, 2020 and with the option to extend the contract if necessary.

WHEREAS, on July 25, 2016, Hawkins County Board of Commissioners approved Resolution #2016/07/03 granting exclusive franchise rights for the operation of ground and convalescence ambulance service to Hawkins County Emergency Medical Service for a period of three (3) years with an expiration of June 30, 2019; and

WHEREAS, the following resolutions have been approved by the Hawkins County Board of Commissioners for ambulance services(s) in Hawkins County:

- July 25, 2016, Resolution # 2016-07-03
- September 26, 2016, Resolution # 2016-09-07

WHEREAS, on June 17, 2020, the Public Safety Committee approved a 3 year extension of exclusive franchise rights to Hawkins County Emergency Medical Services for the operation of ground and convalescence ambulance services for Hawkins County, Tennessee to expire June 30, 2023.

THEREFORE, BE IT RESOLVED that the Hawkins County Board of Commissioners grant an extension of the current franchise rights to Hawkins County Emergency Medical Service for a period of 3 years to expire midnight June 30, 2023.
