#### To Whom It May Concern:

By action of the Board of Commissioners, all applications for Notary Public at Large must be completed by the applicant. This is required for both new and renewal applications. Your application and fees must be received in the County Clerk's Office by (2<sup>nd</sup>) Monday of each month at 4:00 p.m., two weeks prior to the monthly commission meeting which is the (4<sup>th</sup>) Monday of each month. With some months having holidays, the applications may be due by the 1<sup>st</sup> Monday of the month if the Commission meeting is scheduled a week earlier.

### Please complete and submit the following to the County Clerk's Office:

- Application for New/Renewal Notary at Large
- Check or money order in the amount of \$14.00 payable to the Hawkins County Clerk
   Online application fees (2% + .25 cents) will apply

Upon approval by the Hawkins County Commission and the Secretary of State, your commission will be issued to our office. Our office will notify you of the commission expiration date. After notification, you will need to get a Notary At Large Bond in the sum of \$10,000 to bring to our office and receive your commission. You will be responsible for purchasing your own seal.

Pursuant to Tennessee Code Annotated, Section 8-16-109, if a Tennessee Notary Public at Large moves his or her residence or principal place of business out of the county from which the notary was elected and commissioned to another county in Tennessee, the notary is required to notify the County Clerk of the county from which the notary was elected and commissioned.
