PURCHASE AND PLACEMENT OF AUTOMATED

**EXTERNAL DEFIBRILLATOR (AED)** 

WHEREAS, Resolution 2020/08/04 (as amended) addressed the purchase of AED devices to be placed in all county owned vehicles with the purchase not to exceed \$100,00.00. After further research, this is not feasible or necessary and therefore needs to be addressed. Resolution 2020/08/04 was further amended to send this resolution back to the Public Safety Committee to determine where the AED's need to be placed. The Public Safety Committee met on September 11, 2020.

WHEREAS, AED's are not needed in all county owned vehicles and doing so would well exceed the \$100,000 purchase limit.

WHEREAS, Once the AED's are contributed to various non-county owned vehicles & non-county owned buildings, all liability, use, training and upkeep will be the sole responsibility of that agency. For AED's placed in county owned vehicles, the use, training and upkeep will be the sole responsibility of that department within the County. The AED's placed in county buildings will be maintained by the department that is responsible for that respective building.

THEREFORE, be it resolved that AED devices will be placed in *selected* county owned vehicles, *selected* county building locations and be contributed to volunteer fire departments/volunteer rescue squads & E911. The selection of needed locations of the AED's shall be determined by the Director of Hawkins County Emergency Management Agency. Each agency shall coordinate with the local operating EMS Director per TCA 68-140-404 to provide written AED program plan. The purchase price of the AED's shall not exceed \$100,000.00.
