To the HONORABLE RICK BREWER, Chairman, and Members of the Hawkins County Board of Commission in Regular Session, met this 29th day of August 29th, 2022.

RESOLUTION IN REF:

APPROVAL TO RELEASE/CLOSE A PORTION OF MOUNTAIN COVE ROAD AS A COUNTY ROAD AND WILL BECOME A PRIVATE DRIVE TO BE MAINTAINED BY SOMEONE OTHER THAN THE COUNTY.

WHEREAS, Mountain Cove Road intersecting with Slate Hill Road and being Four Tenths (.40 of a mile in length) (approximately 2,188.47 ft), and running in a southernly directions to a dead-end, with a 50 ft right of way, in the Seventh Commissioner District, became a county road via a Right of Way deed dated October 10, 1988 and was added to the road list; and

WHEREAS, the present property owners at the dead end of the road have requested that Hawkins County release/close the last 240 ft of the road, with that portion of the road to become a private drive; and

WHEREAS, the Road Committee met on August 10, 2022 and was presented a notarized closure request form from the property owners, Alberta Adkins, and Cleve and Donna Honeycutt. The committee agreed unanimously to ask the county commission to approve the release/closure of the requested portion of Mountain Cove Road. The portion of road affected will be as follows:

Mountain Cove Road - Beginning at the northern corner of the property line of Alberta Adkins, 182 Mountain Cove Rd (property map 149-B-24) and Cleve and Donna Honeycutt, 175 Mountain Cove Road (property map 149 B -1) and extend southernly to the end of the roadway, approximately 240 ft. (see attached maps)

WHEREAS, upon passage of this resolution, said portion of Mountain Cove Road will become a private drive and Hawkins County will be release, relinquished and discharged from maintaining this portion of the road.

THEREFORE, BE IT RESOLVED that approval be given to release/close the aforementioned portion of Mountain Cove Road as a public road and remove from the road list.


