# HAWKINS COUNTY EMERGENCY ACTION PLAN

## Purpose

This Emergency Action Plan has been developed by the Hawkins County Mayor's Office along with the Hawkins County Emergency Management Agency to define the actions to be taken prior to and immediately following a major disaster occurring in a county facility. The objectives in an emergency are to protect staff and citizens from serious injury, property loss or the loss of life. For the purposes of this plan a major disaster could be any of the following:

- Fire
- Tornado Severe Weather
- Earthquake
- Bomb Threat
- Hazardous Chemical Spill

# **Emergency Alarms and Response Actions**

Notification of an emergency may come from any one or more of the following sources:

- Automated alarm from the fire detection/suppression system
- Commercial radio or television
- Messenger

- Telephone call from an employee or citizen within the building or from local authorities
- Law Enforcement or Emergency Services
- County Alert System

Any person receiving notification of a possible disaster or other emergency should immediately notify their supervisor. If the emergency is a fire, the staff or citizen discovering the fire will also activate the fire alarm.

# Bomb Threat

Most bomb threats will be received by a telephone call to a staff member in the building. Other possible modes of notification, however, do include written correspondence sent by mail or messenger or fax as well as telephone calls to outside parties such as local law enforcement or the media. In all cases, notification should be provided immediately to the supervisor. This notification should include a completed Bomb Threat Checklist (Appendix A) if the person notified is a staff member.

Upon receipt of notification of a Bomb Threat:

- 1. Immediate notification must be provided to 911 (Central Dispatch) so appropriate authorities can be notified.
- 2. Immediate arbitrary evacuation upon initial receipt of a bomb threat is not recommended unless the caller indicates that the time the bomb detonation is imminent. The **s**afest and most expedient way of handling a bomb threat is the Employee Search Plan.

Examine your office space for strange or suspicious items. <u>DO NOT</u> <u>TOUCH</u> any suspicious items. Some bombs are set to detonate upon movement. Report any strange or suspicious items to a supervisor or Law Enforcement Officer immediately. Remember, no outsider knows your areas as well as you do. What appears common place to the outsider may be out of place to you.

3. If the notification indicates that there is sufficient time to conduct a visual search of the building without endangering the safety of staff and visitors, all staff will be notified of the bomb threat and requested to conduct a search only after Law Enforcement has arrived and accessed the situation.

Law Enforcement will determine when it is appropriate to order an evacuation of the building. At such time they will activate the evacuation alarm.

# Earthquake

The initial notification of an earthquake will be when everyone in the building feels the building rolling or shaking. Following pre-planned emergency instructions they will take cover and remain in the facility.

Earthquakes come without warning and are generally of short duration. This should minimize damage and the potential for injuries. In the event of an earthquake:

- Remain calm
- Get under a sturdy object (such as a desk or table) away from glass.
- Cover your head.
- If you are outside, stay clear of falling glass.
- In the event of a fire resulting from an earthquake, follow the county emergency procedures for a fire.

Immediately following an earthquake:

- 1. Contact 911 as soon as possible by any means possible.
- 2. Determine if any individuals were injured by the event and insure that First Aid is rendered when appropriate.

- 3. Supervisors should assess the damage in their immediate area of operation. This includes checking for possible fires, gas leaks, the loss of power and basic services such as water. If gas leaks are found, immediately leave the area and notify 911. The same action should be taken if water leaks are discovered.
- 4. If the earthquake was a major earthquake and the building has been damaged or reports indicate that severe damage has been sustained by the public infrastructure, the Mayor or designee will determine whether or not it is appropriate to activate the Business Continuity Plan.

# **Building Services**

Many of the normal services and/or emergency services may be interrupted because of the scope of an earthquake. Should anyone detect the odor of gas or observe a water leak, they should immediately notify their supervisor.

# **Fire Detection / Suppression System**

#### Alarm: Intermittent audio signal accompanied by flashing strobe lights

Staff and visitors **WILL** evacuate the building to their designated assembly areas. Upon leaving work areas all doors shall be closed and if windows have the ability to be opened shall closed.

• If you SEE A FIRE

1) Pull Fire Alarm. Fire alarms are located by each exit door.

- If you SUSPECT there is a FIRE
  - 1) Call 9-1-1
  - 2) Pull Fire Alarm
  - 3) Evacuate the Office Calmly

## **Fire Extinguisher Locations**

Fire extinguishers are located throughout the building. Key personnel are provided training in their use.

# Don't Be A Spectator

Move away from problem areas. Do not become a spectator or you may become part of the problem.

# **Hot Doors**

- Before opening a door, touch it near the top to see if it is hot.
- A fire on the other side could blast through the smallest opening with tremendous force and heat.

DO NOT OPEN A HOT DOOR.

# **Evacuation Assembly Area**

It is very important that you evacuate to the designated area for head count purposes.

# **TORNATO – SEVERE WEATHER**

Alarm: Determination will be made concerning the type and delivery of this alarm since evacuation is not the appropriate initial response.

Staff and visitors will move from their work areas to designated safe assembly areas within the building (Appendix B)

The supervisor will account for all staff and visitors.

Staff and visitors should remain in the designated safe assembly areas (Appendix B) until the tornado – severe weather has passed or the tornado warning has been rescinded.

Should a "Tornado Watch" be upgraded to a "Warning" condition or should a funnel cloud be observed, all offices will be notified immediately. Each supervisory personnel will ensure that all of his/her staff and immediate citizens in their respective area are moved to the designated safe assembly areas in the building (i.e. hallways, restrooms, courtrooms, windowless areas). At NO time will anyone be allowed to leave the site.

If a tornado should impact the physical facility, supervisors will initiate actions to:

- 1. Render first aid to any staff or visitors that may have been injured.
- 2. Contact 911 immediately for assistance
- 3. Determine the extent of damage sustained by the building.
- 4. If the damage is severe, mayor or designee will determine whether or not it is appropriate to activate the Business Continuity Plan.

# Evacuation

Evacuation routes have been established for all staff and visitors to follow in the event an emergency evacuation of the building is necessary. A map showing these routes for your respective location is on the following page. Additionally, copies of the map are posted by all exits.

Immediately following an emergency evacuation from the building, all personnel and their visitors should proceed to their designated assembly point. The location of each assembly point is also shown on the map and listed in Appendix B.

# **Evacuation Assembly Area**

It is important that management knows that you have safely exited the building when an emergency requires an evacuation of the facility. Please check with your supervisor immediately upon exiting the building. This is the only way of accountability for all employees.

A building evacuation may not result in the end of your workday. You shall be notified by the lead official if the work day has ended.

# Hazardous Chemical Spill

Alarm: Determination will be made concerning the type and delivery of this alarm since evacuation may not be the appropriate initial response.

Initial notification of a hazardous chemical spill will probably come from local officials who have been called to the scene to assess the situation and clean up the spill.

If local officials order an evacuation of the area, all staff and citizens will be advised of assembly points and/or even routes that shall be taken for evacuation.

Local Emergency Services will also provide any other special instructions they may have received from scene.

Staff should ensure that all outside doors, windows and vents are closed.

Staff should remain in their work areas until directed to evacuate the building by the Emergency Services.

Staff should assemble at locations designated when they evacuate the building. All personnel will be advised if they need to evacuate the site and if so what route will be taken.

## RESOLUTION IN REF: ADOPTION OF ADDITIONAL POWERS PURSUANT TO TCA §5-1-118

WHEREAS, *TCA* § 5-1-118 provides, inter alia, that the County by two-thirds (2/3) vote of the County Legislative Body may adopt and exercise those powers granted to municipalities pursuant to *TCA* § 6-2-201(22)(23) except as otherwise provided in *TCA* § 5-1-118; and

WHEREAS, it has been determined that Hawkins County, Tennessee needs to adopt these additional powers for the purpose of regulating businesses, promoting the general welfare pursuant to the health, morals, comfort, safety and convenience of its inhabitants, prescribing limits which business occupations and practices may be established, conducted or maintained, exercising general police powers and any other matters as set out in the aforesaid section.

THEREFORE, BE IT RESOLVED that Hawkins County, Tennessee hereby approves and adopts the additional powers set out aforesaid pursuant to TCA § 5-1-118.

### 5-1-118. County powers shared with municipalities.

(a) Counties, by resolution of their respective legislative bodies, in addition to other powers authorized by general law or private act, may exercise the following powers granted to all or certain municipalities by the following code sections:

(1) Section 6-2-201(3)-(8), (10)-(13), (18), (19), (26) and (28);

(2) Section 6-54-103;

(3) Section 6-54-110;

(4) Section 6-54-307; and

(5) Sections 6-54-601 - 6-54-603.

(b) Nothing in this part shall be construed as granting counties the power to prohibit or regulate normal agricultural activities.

(c)(1) In addition to those powers granted to counties pursuant to subsection (a), any county may, by adoption of a resolution by a two-thirds (%) vote of their respective legislative bodies, exercise those powers granted to all or certain municipalities by § 6-2-201(22) and (23), except as provided in subsection (b) and subdivisions (c)(2) and (3). Any such regulations shall be enacted by a resolution passed by a two-thirds (%) vote of the county legislative body. The powers granted to counties in this subdivision (c)(1) apply only within the unincorporated areas. Nothing in this subdivision (c)(1) may be construed to allow any county to prohibit or in any way impede any municipality in exercising any power or authority the municipality may lawfully exercise. If, prior to April 17, 2002, a county has adopted a resolution by a two-thirds (%) vote, pursuant to previous acts enacted by the general assembly, to exercise the powers granted in accordance with this subdivision (c)(1), no further action by the legislative body of such county is necessary to continue exercising such powers.

(2) The powers granted by § 6-2-201(22) and (23) shall not apply to those activities, businesses, or uses of property and business occupations and practices that are subject to regulation pursuant to title 57, chapters 5 and 6; title 59, chapter 8; title 60, chapter 1; title 68, chapters 201-221; or title 69, chapters 3, 7, 10 and 11.

(3) All court decisions and statutory laws relating to variances and non-conforming uses applicable to zoning ordinances and land use controls shall apply to the enforcement and exercise of those powers granted pursuant to subdivision (c)(1).

## TCA § 6-2-201 General powers.

(22) Define, prohibit, abate, suppress, prevent and regulate all acts, practices, conduct, businesses, occupations, callings, trades, uses of property and all other things whatsoever detrimental, or liable to be detrimental, to the health, morals, comfort, safety, convenience or welfare of the inhabitants of the municipality, and exercise general police powers;

(23) Prescribe limits within which business occupations and practices liable to be nuisances or detrimental to the health, morals, security or general welfare of the people may lawfully be established, conducted or maintained;
